Item No. 2: To discuss about Annual General Meeting.

Mr. Yogesh Aggarwal - CAG Nominee suggested that any observations by the auditor in its report should be complied with and suggested to adopt a Procurement and HR policy. He was informed that the association has already adopted Procurement and HR policy.

After discussions it was unanimously resolved to approve the documents circulated to them regarding AGM and decided that as per the constitution of CAU, President will take a call and fix the date and venue for AGM, therefore the President may take a call on it.

Item No. 3: To Discuss Medical Policy for Players.

Hon. Secretary recommended that CAU should have a Medical Policy for Players, and therefore we should first study the prevalent medical policies for players in other state associations. It was also discussed that a working panel should be constituted to study and draft this policy.

Apex Council unanimously accepted the suggestion of Hon. Secretary and constituted a working panel comprising of Mr. Avnish Verma - Hon. Jt. Secretary and Mr. Mohit Dobhal -Interim Chief Executive Officer to draft a medical policy for players of CAU and submit it to the Apex Council for consideration.

Item No. 4: To Consider any other matter.

Hon. Secretary briefed the house about few issues which CAU is facing which needs to be acknowledge and resolved with utmost importance i.e., many outside players are coming and participating in various selection trials in Uttarakhand since the eligibility criteria is very easy to be fulfilled, he proposed to constitute a working panel to frame eligibility criteria/conditions and registration rules for all the players who intend to play for CAU.

Mr. Avnish Verma - Hon. Jt. Secretary also suggested that certain rules and regulations should also be framed for conducting any sort of tournament by any district in the state.

Apex Council unanimously accepted the above suggestions and constituted a working panel comprising of Mr. Sanjay Rawat - Vice President, Mr. Mahim Verma - Hon. Secretary and Mr. Gyanendra Pandey - ICA Nominee to do the needful and submit its report to Apex Council for consideration.
